Enclosed you will find the following forms required to run for a seat on the Board of Directors.


1. Application/Nominee Form

- Collect signatures from **CMWSC members in good standing**.
- We strongly recommend gathering **more than 20 signatures** to account for any potential disqualifications.

3. Verify Signatures

- Once you have the required 20 signatures, visit our office to confirm their validity. Our staff will verify that all signatories are qualified members in good standing.

Important: If you do not have 20 valid and qualified signatures, your application cannot be accepted.
